Personally appeared before me, the undersigned authority in and for the jurisdiction aforesaid, Dr. Jeffrey H. Bass, who being by me first duly sworn, states on oath as follows:

1. My name is Dr. Jeffrey H. Bass. I am over 21 years of age and am not a convicted felon. I have personal knowledge of the facts stated herein.
2. I am licensed to practice medicine in California and Mississippi.
3. I have never diagnosed anyone, including but not limited to any individual on the list attached as "Exhibit A," with asbestosis or silicosis.
4. I have never prescribed or ordered an x-ray, Pulmonary Function Test ("PFT"), or any other diagnostic test in connection with the screening of individuals for asbestosis or silicosis.
4. I do not have any records or documents that are responsive to the subpoena issued by the United States District Court for the Eastern District of Pennsylvania in *In re Asbestos Prod. Liab. Litig. (No. VI)*, MDL No. 875, hereto attached as "Exhibit B."
5. In my work for Healthscreen, any other litigation screening entity, or plaintiffs' firm:
  - (a) I did not review any x-rays;
  - (b) I did not render any B reads;
  - (c) I did not receive direct payment from any individuals who ultimately filed a lawsuit;
  - (d) Out of the thousands of individuals for whom I issued reports, I only

performed approximately 20-30 physical examinations.


(e) I did not, to my knowledge, meet in person any of the individuals whose records were forwarded to me for review; and

6. I submit this affidavit in support of the truthfulness and accuracy of my statements contained in the document attached hereto as "Exhibit C."


